Ampyr Energy USA has a goal of building a 5GW utility-scale solar PV platform across multiple US markets. The two partners formed Ampyr Solar Europe (ASE) two years ago with the goal of rolling out 5GW of large-scale solar projects, with aims to establish itself as one of the largest utility-scale solar platforms in Europe.

The AMPYR Energy USA team did not reveal which US states they will focus on, but management did announce that the company will look to develop both solar-plus-storage and standalone PV plants.

AMPYR Solar Europe (ASE) was created in 2021 through the merger of NaGa Solar with the existing AMPYR Energy UK joint venture between AMPYR and Hartree Partners. The combination established a major new European solar independent power producer (IPP) with a combined pipeline of over 7GW of large-scale ground-mount and rooftop solar projects in ...
