What is a disassembled solar panel?

These panels often originate from disassembled solar installations, which may be due to upgrades, damage repair, or the dismantling of a solar project. Any solar panel that has changed hands from its original owner, be it an individual, a corporation, or any entity, qualifies as used.

How do I get rid of a defunct solar panel?

Give your defunct solar panels to your solar panel installer. Under EU regulations (which still apply, even post-Brexit), your solar panel installer is legally obliged to take your defunct solar panels off you, or at least fund a Distributor Take-back Scheme (DTS).

If you're a business who wants to recycle your solar panels, there will likely be a charge. The cost of this will depend on the amount of solar panels you have, the type and the logistics.

It's most likely they'll take your panels to a Designated Collection Facility (check the DFC database to find one near you) before the panels go on to a recycling point.
