

Do Caymanians have Amerindian heritage?

Therefore, native Caymanians do not have any Amerindian heritage from their own islands; however, a significant number of Jamaicans have settled in the Cayman Islands over the years, so they and their descendants may have some Amerindian blood via Jamaica.

Where are the Cayman Islands located?

The Cayman Islands (/ˈkeɪmən/) is a self-governing British Overseas Territory, and the largest by population. The 264-square-kilometre (102-square-mile) territory comprises the three islands of Grand Cayman, Cayman Brac and Little Cayman, which are located south of Cuba and north-east of Honduras, between Jamaica and Mexico's Yucatán Peninsula.

What ethnic groups live in the Cayman Islands?

South Asians, mainly Filipinos and Indians, as well as Caymanians of South Asian descent, make up 8.1%, and the remaining 2.6% belong to various ethnic groups. The official language of the Cayman Islands is English.

What currency is used in the Cayman Islands?

All values, unless otherwise stated, are in US dollars. The economy of the Cayman Islands, a British overseas territory located in the western Caribbean Sea, is mainly fueled by the tourism sector and by the financial services sector, together representing 50-60 percent of the country's gross domestic product (GDP).

Which countries live in the Cayman Islands?

The largest numbers of expatriates living in the Cayman Islands hail from Jamaica (11,703), the United Kingdom (1,708), the Philippines (4,119), and India (1,218). Approximately 8,139 more residents are citizens of various other countries.
