How long will Centrica's nuclear power stations last?

The extensions will see Heysham 1 and Hartlepool generating electricity until March 2027, while Heysham 2 and Torness will continue until March 2030.

How will Centrica's terawatt extension affect UK power generation?

These extensions will add 9TWh [terawatt hours] to Centrica's electricity generation volumes between 2026 and 2030. The move supports the UK's baseload power generation, aligning with the country's net zero ambitions and maintaining grid stability amid increasing renewable energy integration.
