

Will Centrica sell its gas assets in Trinidad & Tobago?

Centrica plc has agreed to sell its entire portfolio of gas assets in Trinidad and Tobago to Shell Exploration and Production for an initial cash consideration of \$30 million (£24 million).

When did Centrica enter Trinidad & Tobago?

Centrica entered Trinidad & Tobago in 2010 with the acquisition from Suncor of interests in NCMA-1 and Blocks 22, 1a and 1b. It was awarded its interest in NCMA-4 as part of a shallow water bid round in the same year. In April 2016 Centrica sold its 80 per cent operating interests in Blocks 1a and 1b to De Novo Energy.

Why did Centrica buy FlowGem?

Centrica sold its portfolio of gas assets in Trinidad and Tobago to Shell Exploration and Production in line with the strategic decision made in 2015 to focus its E&P activity on European assets. Centrica acquired FlowGem Limited, an early stage UK-based business developing unique and innovative technology to remotely detect water leaks.

Why did Centrica acquire CQ Energy Canada partnership?

The acquisition added further capabilities and geographical diversification to the Energy Marketing and Trading business. Centrica disposed of its 60% interest in The CQ Energy Canada Partnership, a Canadian exploration and production joint venture, in line with the strategic decision made in 2015 to focus its E&P activity on European assets.

Why did Centrica buy smartwatt?

Centrica announced that it had purchased SmartWatt, a leading energy services and solutions company. The acquisition broadened the Group's footprint in the U.S. and enhanced Centrica Business Solution's capabilities to meet increasing customer demand for integrated energy solutions.

What acquisitions & disposals has Centrica made?

Since 2015, we have made the following acquisitions and disposals: Centrica sold its 382 MW King's Lynn combined cycle gas turbine power station to RWE Generation, consistent with Centrica's strategy to reposition from central to distributed generation.
