

Do companies need to apply for approval to install photovoltaic panels

Do you need planning permission to install solar panels on your roof?

An increasing number of people are investing in solar energy. More and more homes are having solar panels, or solar tiles, installed on their roofs. Of course, with such installations, the topic of planning permission and building regulations often comes to the surface.

Can I install solar panels if I don't meet building regulations?

Your local authority can also apply for a Confiscation Order to take away any money you've earned with your system - so there's absolutely no benefit to installing solar panels that don't meet building regulations. It's crucial that your solar installation follows all building regulations.

Do solar panels need planning permission?

Your installer should be MCS certified and a member of a CPS for microgeneration technology, such as NICEIC. After commissioning of the system, you will receive certificates to prove it meets the required regulations. In most cases, solar panels do not require planning permission as they fall under permitted developments.

Can solar panels be built without permission?

This is because they generally fall under permitted development rights, which allow homeowners to make reasonably sized changes without getting permission. The exceptions to this rule are typically flats, listed buildings, homes in conservation areas, and ground-mounted installations. What are the building regulations for solar panels?

Do I need a building regulations certificate for my solar panel system?

You should receive a building regulations certificate, known as a completion certificate, for your solar panel system. This certificate will assure you and any future owners that the work met all building regulations, which will make it much easier to sell your property at any point.

How do I apply for planning permission for solar panels?

If you need to install solar panels on a listed building or within the curtilage of a listed building or designated landscape, follow these steps to apply for planning permission: Consult Your Local Planning Authority (LPA): Contact your LPA to discuss your plans and get advice on the application process.
