

## GoodWe photovoltaic inverter warranty period

Does goodwe solar inverter come with a warranty?

Goodwe solar inverter products come with a standard manufacturer's warranty of 60 months or 5 years between the following two dates: There is also the option to purchase a warranty extension for your GoodWe solar inverter. For NS, DNS, DSS, DT, SDT, LVDT, and MT series, the available extended warranty periods are 7, 10, 12, 15, 20, and 25 years.

What is a 10 year warranty on a goodwe inverter?

The extension applies to all GoodWe inverters manufactured after October 1, 2020 and installed in Australia after January 1 this year. 10 years is a generous warranty for what is a cheap, but decent quality inverter.

How long does goodwe warranty a DNS inverter?

From the date of production. For the DNS, DNS G3, MS, MS G3, series inverter, GOODWE provides additional 5 years (60 months) Spare parts warranty on top of the original 5 years manufacturer's warranty. During this period, only the hardware costs of the spare inverter to replace the

What is goodwe's warranty on grid connect inverters?

Up to this point, GoodWe's standard manufacturer warranty for grid connect inverters has been 5 years, with the option to extend out to 7, 10, 12, 15 and even 25 years in some cases - but this involves extra cost.

Does goodwe offer a warranty on a cement inverter?

If the inverter is damaged by cement, it will be extended to a full one-year warranty. For every single inverter exchange case, the claimant must gather the necessary information and send the RMA report (by following GOODWE's RMA template) to GOODWE to confirm

What is a goodwe limited warranty?

This limited warranty replaces all other GOODWE warranties and liabilities, whether oral, written, (non-mandatory) statutory, contractual, in tort or otherwise, including, without limitation, and where permitted by applicable law, any implied conditions, warranties or other terms as regards satisfaction
