Can Europe import solar panels from China?

Why should you import solar panels from China?

Both the tariffs and the fact that China is the largest producer of solar panels globally make importing them from this country beneficial. As one can see, the duty rates on solar panels imported from China to the EU are very low, and in this case, they're zero.

Should solar panels be imported?

However, for the solar sector specifically, there is no strong economic justification for an import-substitution approach. Such a strategy risks increasing the costs of solar panels, slowing deployment and creating industries that are over-reliant on subsidies.

Can a country import solar PV technology?

Countries that import solar PV technology can however build a local industry around the installation and O&M industries, consisting primarily of jobs which require a lower level of technical expertise.

Which countries export solar panels in the EU?

The largest extra-EU export destination for wind turbines was the United Kingdom (30%), followed by the United States (18%). China (98%) was by far the largest partner for extra-EU imports of solar panels in 2023 (see Figure 5). The largest extra-EU export destinations for solar panels were Switzerland (31%) and the United Kingdom (25%).

How many dumping and import taxes are imposed on solar PV?

Since 2011, the number of antidumping, countervailing and import duties levied against parts of the solar PV supply chain has increased from just 1 import tax to 16 duties and import taxes, with 8 additional policies under consideration. Altogether, these measures cover 15% of global demand outside of China.
