In India, a microgrid was first pioneered in the 1990s by the West Bengal Renewable Energy Development Agency (WBREDA) when it installed a 25KWp solar PV system in the Sundarban delta region. Subsequently, the Chhattisgarh Renewable Energy Development Agency (CREDA) initiated a solar plant in the Bilaspur district.
