

Does Italy have a power purchase agreement (PPA) market?

Why is the PPA market growing in Italy?

In May 2019, it was announced that DXT Commodities, Duferdofin Nucor and Fera had agreed the first wind corporate PPA in Italy.

Why is demand for PPAs increasing in Italy?

Indeed, demand for PPAs in Italy is on an upward trajectory both from corporate buyers as well as utilities/sellers. One of the major drivers pushing this response from wide-ranging market players is what's known as "FER X" legislation.

How much electricity does Italy generate a year?

In total, Italy's clean electricity generation hit a record 88 terawatt hours (TWh) during the January to August period, compared to 73.4 TWh during the same months in 2023.

The PWA credit bonus is available for credits under Sections 30C, 45, 45Q, 45V, 45Y, 45Z, 48, 48C, and 48E, and the energy efficient commercial building deduction under Section 179D. In general, taxpayers that meet the PWA requirements in constructing, repairing, or altering facilities may be able to claim a credit five times the base rate.
