How many ships did Sea Malta own?

The three old ships Marsa, Gudja and Mdina were laid up in 1976 and in the same year, the company purchased the ship Qormi in order to provide better service to Europe. Another ship was bought in 1976 and named Dwejra II . In 1979 Sea Malta also participated directly in the establishment of the national towing company, Tug Malta.

What happened to Sea Malta?

Therefore, Sea Malta, one of the icons of Malta and which always served the nation, was liquidated. The ship Zebbug was sold to Fergun Lines and renamed Fehim Bey, still operating to Malta. The Maltese Falcon was purchased by Grimaldi Lines, keeping the same name and sailing until 2009 when it was scrapped in India.

The company, which employed around 144 workers, served the national economy by providing sea transport services for the local manufacturing and retail enterprises.
