How can China reform urban and rural development?

To reform urban and rural development,Zhang said the guideline includes an action plan to integrate the country's ambitious climate goals-ensuring carbon dioxide emissions peak before 2030 and realizing carbon neutrality before 2060-into the building sector.

What is the policy related to solar energy development?

The only policy related to solar energy development is the supply-side R&D policy to promote and follow the development of solar technology. For the demand-side,Solar PV was planned by the government as the solution for non-electricity remote areas.

Does China's solar policy influence the development of the solar industry?

However,based on the limited studies on China's solar PV policies,the literature only lists China's existing PV solar policies ,,which cannot explain the dynamic trajectory of Chinese solar policy and its relation to the development of the industry.

Does China have a solar PV policy?

To our knowledge, rare studies make a comprehensive analysis on China's solar PV policies, particularly on policies implemented during 2011-2012. The purpose of this paper is to make an effort to fill this gap. It contributes to the academic literature over China's solar PV power policies.

What is the Green Building Regulation?
