Neoen is one of the world's leading independent producers of exclusively renewable energy. The geographical and technological diversity of our assets and project portfolio underpins our development and performance. Our "develop to own" business model is unique. We own nearly 93% of our plants, and operate them in our own name in the long term.

What markets does Neoen operate in?

Neoen operates in the solar power, onshore wind farm and battery storage markets. Its turnover for 2023 was EUR524.4 million, made up of 41% solar power (EUR213.7 million, an increase of 10% year on year), 48% wind power (EUR251.2 million, 16% increase) and 11% storage (EUR58 million).
