How did Sapura Energy perform in FY2016?

Sapura Energy maintained a robust operational and financial performance for the year. The Group achieved PAT of RM206 million, compared to the previous year's loss after tax of RM791 million. The improving industry environment has led to significantly lower impairment of RM283 million as compared to RM2,029 million in FY2016.
