

What are the new solar rebates in Norway?

Norway's clean energy agency Enova will increase the maximum PV system size eligible for rebates from 15 to 20 kW and the maximum subsidy amount from 1,250 to 2,000 NOK (\$226.7) per kW installed. In addition, new subsidies of up to 10,000 NOK will be introduced for energy management systems that are often installed alongside solar arrays.

Will Norway continue to invest in solar panels?

In addition to this, an analyst from a solar company predicts that by the year 2030, solar energy through rooftop will be able to provide up to 30-40-Terawatt hours' worth of electric power. Therefore, Norway shows and will continue to show high interest and investments in solar panels.

How much solar power does Norway have in 2020?
