

# What is the crime of reselling national photovoltaic panels

Can you sell off excess solar energy?

One way is to install new rooftop solar panels. Doing so, from the 1st of January 2020, means you will be able to sell off any excess renewable energy. The new initiative to provide guaranteed payments comes from Smart Export Guarantee (SEG). They will enforce a legal obligation for most energy suppliers to bid for electricity.

Can solar energy be exported back into the National Grid?

But that excess energy can be used elsewhere, by exporting it back into the National Grid, which then distributes it to wherever it is needed. The good news for solar panel owners is that large energy companies are obliged to pay for the excess energy that is exported, under the Smart Export Guarantee (SEG) scheme.
